# Leaving a special gift

## Making a gift in your Will

We believe it's important you discuss any changes to your Will with your legal advisor. If you don't already have a Will we respectfully recommend you contact your solicitor or other legal advisor to ensure your wishes are correctly and legally stated.

## In memoriam giving

A memoriam gift is a wonderful way to celebrate and remember a loved one or friend who has passed on. A donation to the Neurological Foundation in their memory will go towards funding ground-breaking research into one of the 700+ neurological conditions that exist today.

Many families choose to honour their loved ones by requesting donations to the Neurological Foundation in lieu of flowers at a funeral. A tax-deductible receipt will be sent to all donors and an acknowledgment of contributions will be sent to the family or next of kin.

## A living gift

A living gift is a unique way to leave a memory that you and your loved ones can see the results of within your lifetime. In doing so, you'll be able to fund research that needs funding now and experience the outcomes of those specific projects. You and your loved ones will be able to share in your lasting gift together. If you are able to make this type of generous gift, we suggest discussing this option with a member of our donor relations team.

## Here's what you need to know

The best way to help continue supporting the Neurological Foundation for generations to come is to leave a monetary gift, and one that is a residuary bequest. This is what remains after all your other provisions have been made, enabling you to put your loved ones first. There are other options too such as a pecuniary bequest – this means a specified sum of money is left in your will to the Neurological Foundation, or a specified bequest, where a particular item of value (for example stocks, property, or works of art) is left to the Neurological Foundation.

**If you wish to leave a bequest to the Foundation, you should contact your solicitor or trust company and ask for the following clause to be inserted in your Will:**

I give to the Neurological Foundation of New Zealand the sum of \$..... (or a ..... share in the residue of my estate) for the general purpose of the Neurological Foundation (or for a specific purpose) and I declare that the official receipt of an authorised officer of the Neurological Foundation shall be sufficient discharge to my executors.

Let the work you've done in your lifetime be the change that lives on for the next generation. The Neurological Foundation would not be what it is today without the generous support of people like you. Including us in your Will is a big decision, and we couldn't continue funding the world-class research we do without your generosity. We would like to share our warmest gratitude for considering leaving us a bequest.
